

Carl Hill: agent provocateur and bag-man for the Lubrizol Corporation, and the Amway Corporation.

Agent Provocateur: (Merriam Webster Dictionary)

A person hired to infiltrate a group and incite it's members to illegal action.

Bag-man: (Merriam Webster Dictionary)

A person who collects or distributes illicitly gained money on behalf of another.

History: Carl Hill, a resident of Michigan, infiltrated Polar Molecular Corporation (PMC), and Polar Molecular Holding Corporation (PMHC) in 2006 through a PMHC Board Member, Richard Socia, and became a PMHC/PMC consultant.

In 2006 he undermined a multi-million dollar Duralt distribution deal in the truckstop industry through compromising of other PMC/PMHC members . In 2007 he torpedoed a \$10 million PMHC preferred stock offering in conspiracy with Socia. In 2007 he, and Socia, after killing the financing, convinced a secured lender to engage in foreclosure conspiracy on the PMC/PMHC Duralt patents and trademarks. In 2009 he compromised a court appointed "trustee", and with Socia, the secured lender, and a (Amway) law firm conducted a fraudulent auction of the PMC/PMHC Duralt patents and trademarks. Six months later in March 2010, Hill, Socia, the secured lender, and the (Amway) law firm abandoned the Duralt patents and trademarks through non-payment of annities, and maintenance fees due. After the abandonment of the Duralt patents, Lubrizol manufactured Duralt Plus detergents (the subject of the abandoned Duralt patents)and sold it to Amway for sale on the Amway website, as "XLP". Also in 2010, Hill compromised a material witness in a perjury conspiracy to cover up the undermining of the financing.

This led up to the acquisition of Lubrizol by Warren Buffett's Berkshire Hathaway in March 2011. (All of the above is documented in the Brief and exhibits on this website entitled Bankruptcy Fraud).

Since the above events, Hill has continued to act as an "agent provocateur", and "bagman" inciting illegal acts, retaliation against witnesses, tortious interference of PMHC business deals, cyber crime, "stalking" of a witness and other illegal acts.

As a "bag-man" Hill has made bribes and payoffs to a growing number of persons he has compromised and illicited to illegal action, sometimes in violation of confidentiality law and the United States Economic Espionage Act.

The below photos are a few incidences of "retaliation" and "stalking" a witness, Mark Nelson, at St. Mark Catholic Church in Highlands Ranch, Colorado. Hill, a resident of Michigan isn't there for the sermons, he is there because Mark Nelson is there.

There have been other serious acts of retaliation against the Nelson family and love ones for which Mark Nelson believes Hill is complicit.
